Chairman's Remarks

After a winter filled with travel it was nice to get back to MVA<sup>™</sup> Headquarters in Slidell Louisiana for a bit. I do think that Robin, Chandra, and Quentin are hoping that I go back on the road again since I keep disturbing them with my latest ideas. Robin says she gets a lot of work done when I am not around, and I think she is right. But brainstorming with staff gives rise to some of my better ideas and quashes some ideas that are not so good. We are lucky to have these folks working with us. They have allowed us to grow as an organization.

What's going on with the PACT Act? Good question. It passed the House and went to the Senate. The Senate Veterans Affairs Committee held a legislative hearing on March 29. A lot of good information, but the bottom line is that the cost is still stopping it. MVA<sup>™</sup> supports the PACT Act and has joined with several other veterans groups to promote it. If it does not pass the Senate, we will still continue to promote the Tester-Moran phased approach as reflected in S 3541/HR 6659. Additionally we are pushing for adoption of smaller, less expensive bills such as HR 3368, HR 2269/S657, HR 5026, HR 1585/S565 and HR 2580/S1151.

On St. Patrick's Day I gave an on-line personation to 20 Pennsylvania attorneys to introduce them to VA law. The presentation was approved for Continuing Legal Education credit by the Commonwealth of Pennsylvania and we received good feedback on the presentation. Teaching VA law to attorneys is one of MVA's<sup>™</sup> primary missions. Bringing more attorneys into the VA system is the key to winning additional benefits for veterans. By popular demand I did not include my infamous rendition of "When Irish Eyes are Smiling!"

On April 8 I will be participating in a seminar with Loyola Law School of Chicago on disability benefits including Social Security disability and veterans benefits. A video will be made available at a later date. On May 9, Brian Moyer and I will be presenting an update to the Central Florida Veterans rally.

The week of May 15 thru May 19 will see our return to Washington, DC. Chief of

Staff Mike Kvintus, Legislative Director Ernest Dillard and I will join Vice-Chairman Sgt. Major Jim Kuiken USMC (ret) and his service dog Freedom for visits on Capitol Hill. We expect to discuss the PACT Act, HR 3368, HR 2269, and HR 5026 as well as other critical legislation.

Our 4th Annual Rifle-Raffle (aka Rif-Raf) is now ongoing. This year we are raffling off a Remington 870 shotgun, a Model 1911 .45 caliber pistol, a steel target (donated by Brian Moyer), and \$250.00 cash. Look folks, Chef Warren makes a french toast casserole that is to die for. Space is limited, so sign up now. Sponsorships are also available.

No word yet on the promised appointment with the VA Secretary. Still waiting.

OK let's talk fund-raising. Why are we asking for money so often? Well because we need it. We have three employees now and we need to meet payroll. These three folks have been force multipliers and frankly our volunteers would collapse under the administrative responsibilities if we did not have them. Quentin has done a great job in the Marketing/Fundraising arena. He has also been essential in our social media communications program. Chandra has taken over scheduling duties from Susie as well as legislative/fundraising tracking. Robin, well Robin just does everything else. She keeps our accounts, ensures the IRS is happy, and coordinates Board and Executive Committee meetings. She also handles inquiries from members and processes all of our membership applications/renewals. She is a true Super-Woman.

Plus we have made a number of management upgrades. Our new QuickBooks upgrade costs us several hundred dollars per year. Our new web site fundraising will cost a few hundred dollars per year. Our legislative tracking software costs a few thousand per year. MVA<sup>™</sup> is paying half the cost of the office rent. I pay the other half.

Look, I get it. Times are tough and once you have filled your gas tank and bought some food there is not a lot left over for charitable giving. But there are things you can do. Buy a rifle raffle ticket or by a chance for our Fall Foliage trip once we start selling those tickets. Or set up for a small donation every month. Our new system allows you to contribute monthly or quarterly if you so desire. Even \$10 a month mounts up. So please consider helping. Each trip to DC eats up about \$10,000 in airline fares, hotel fees, meals, and taxi/uber/metro. Remember, none of your board members take a salary.

Tentatively we are looking at mid to late August for an online veterans law CLE. It will be open to members, non-members, and attorneys. More information on that to follow.

### **LEGISLATION**

### **New Legislation**

Rep. Jack Bergman (MI-01) and Rep. Colin Allred (TX-32) introduced "Gerald's Law", H.R. 7176, to close a loophole that denies certain terminally ill Veterans their VA burial allowance if they do not pass away at a VA facility. Bergman's bill would expand eligibility for the VA benefit, applying the burial allowance to terminally ill Veterans that were discharged from receiving care at a VA hospital or nursing home to pass comfortably at home under hospice care. "Veterans who have sacrificed for our Nation should not have to sacrifice their surviving family's burial benefit for choosing to pass away in the comfort of their own homes. This happened to Gerald but is inexcusable and should never happen again."

MVA<sup>™</sup> supports HR 7176.

# **Litigation**



Our cases at the Court of Appeals for the Federal Circuit are still waiting a decision. Normally decisions are rendered 3-5 months after oral argument, however it can take longer. Ours is a complicated case and we have to recognize that the Judges are taking their time to try to get it right. At issue is herbicide relief for Guam, Johnston Island, American Samoa, Thailand, the airspace over Vietnam, and the extension of the Blue Water Navy line to include the entire Vietnam Service Medal area.

### **RULEMAKING**

MVA<sup>™</sup> currently has three major rule making requests that have been approved by the VA. These requests will cover herbicide exposure in Thailand, Okinawa, and the Panama Canal Zone. Our problem is that there is no timeline required for the VA to issue the notice of proposed rulemaking in the Federal Register. In other words, the approved requests can sit in the VA hold baskets forever. We have reached out to the Senate Veterans Affairs Committee staff on both the Majority and Minority sides and asked them to include a timeline not to exceed 27 months for completion of action on rule making requests. Both sides are amenable to further discussion on this issue. Under our proposal, the VA would

be required to decide whether or not to approve the request within 15 months and complete action within 12 months thereafter. We will keep you up to date on the progress of this request. If a rule making request is denied or we do not like the rule, we will be able to seek judicial review.

## VA Life Insurance for Disabled Veterans

Service-Disabled Veterans' Insurance (S-DVI) provides life insurance to Veterans with service-connected disabilities with basic coverage up to \$10,000 and supplemental coverage up to \$30,000. Interested Veterans should apply for S-DVI by December 31, 2022. S-DVI enrollees may also consider VA Life Insurance (VALI), a new program taking effect in January 2023.

# **Voter Assistance at VA facilities**

Message from the VA

As part of a government-wide effort to tackle barriers to voting that many Americans face, VA announced a new initiative this week to provide voter assistance to Veterans, families, caregivers and survivors at VA facilities across the country. VA is doing this because we recognize that advocating for all Veterans include advocating for their ability to exercise the rights they fought for and to participate in the civic life that they defended in uniform. During his speech at the 57th anniversary of Bloody Sunday in Selma, AL, Deputy Secretary Donald Remy said, "For too long, too many Americans have fought too hard around the globe to protect our rights and freedoms only to fight brutal battles here at home for their own rights and freedoms." This work ensures "Veteran access to that most sacred right they fought for and so many died for."

As part of this effort, our goal this year is to establish a pilot voter assistance program in select facilities in six states where Veterans and their families, caregivers, and survivors can go to receive voter assistance information and support.

The VA Secretary has granted our Rulemaking Request. Our Chairman and other Board directors have been in DC of late to work towards getting the VA Secretary to follow through on his promise of granting for not only Panama veterans, but also Okinawa and Thailand veterans. MVA<sup>™</sup> is continuing to push for benefits for all those exposed to toxins.

### House passes Congresswoman Newman's amendment on study of Panama Canal Veterans impacted by Agent Orange

As part of the Honoring our PACT Act, the House of Representatives on Thursday March 3, 2022 passed Congresswoman Marie Newman's (IL-03) amendment to require the Department of Defense (DOD) to conduct a study on veterans who served in or near the Panama Canal Zone and may have been exposed to deadly tactical herbicide, also known as Agent Purple or Agent Orange. We are hopeful that Panama veterans will finally be studied in the near future.

This Amendment builds on Rep. Newman's Panama Canal Zone Veterans Act, which would grant federal benefits to Panama Canal Zone veterans who were exposed to deadly tactical herbicide. Click <u>here</u> to watch Congresswoman Newman's floor speech on the amendment.
