Currently a diesel electric submarine must have traveled within 12 nautical miles of Vietnam to qualify for BWN. These submarines ingested copious amounts of air during snorkeling operations, week after week, to operate diesel engines and breathing air for the crew. Drinking water was distilled from surrounding sea water. At least 50 made numerous Westpac trips without ability to qualify as much of there trip itinerary was classified Special Operations, and locations are unavailable. VA claims are denied because proof of locations can't be determined, either in or not within 12 nautical miles. Solution is to approve a claim, when a document with specific locations can not be found and read by qualified person. Benefit of doubt should be given to veteran for presumptive exposure to Agent Orange.

I served on The USS Oriskany CV/CVA-34 73-74. In 73 our ship (an aircraft carrier) was in and around Yankee Station and The Philippines. In the territorialwaters of Vietnam there were combat and mail planes flying in and out of Vietnam and returning to the carrier in which I was stationed on at that time. These planes were washed down on the flight deck were water ran, splattered, and puddled on deck; plus, ran across the deck and along bulkheads and into the water drains or on decks below. Drinking from water fountains aboard the carrier [at times] tasted like oily fuel in the water.

While docked in the Philippines @ Cubic Point there were pallet of barrels leaking chemicals along the pier where myself and many other walked in puddles of liquid; plus, years later waters in Subic Bay and Cubic Point were deemed hazardous disaster areas whereby the United States funded Millions of US dollars to clean up those sites (https://mandalaprojects.com/ice/ice-cases/subic.htm); (http://www.cpeo.org/lists/military/2002/msg00842.html);

When they landed the planes they would stag them on our cat fuel and other stuff off the planes mostly jets leaked onto the deck an into the catapult itself. When we launched the next launch the steam from the cat shot would heat up the toxic stuff and turn it to vapor WHICH we all BREATHED into our LUNGS and onto our close and our bodies. At one time while on the alert Five watch they landed a helicoptor on the cat which had been shot up by Viet Cong We had to place the sills into the cat tracts it was to late the Agent orange was already on into the cat itself. The cuper drains where the seals were soaked with the fluid our gloves were soaked as was our bodies from all this. We would work the next launch opps in the same close and be exposed to all the same elements again for Days

Flight deck working parties / Ordnance handling

Toxic Exposure Rule Comments

I was stationed on the USS Coral Sea (CVA-43) from 01 AUG 1967 to 27 MAY 1968. This was the ship's third combat tour and it consisted of five line periods that comprised 132 line days of combat operations. During those periods of being on the "line" it seemed like there were never more than a few days between at-sea replenishments (unreps) where we were taking on either fuel, stores, or armaments ... sometimes more than one unrep in a day. We had no way of knowing if any of the cargo we were loading had been staged in Vietnam, Guam, or somewhere else. I served on many (too many to count) of these working parties where we were moving stores or armaments from the flight deck to the storage areas. During my first two months onboard I spent a short time assigned to G-Div. moving bombs before being assigned to a Zuni rocket crew. We were tasked with loading the rocket pods and, after flight ops we would unload any unused rockets, test the pods, and reload. On 11 OCT 67 I was transferred to S-7 Div. where most of my time onboard entailed processing of flight operations so we had little to do when the planes weren't flying. As a result, most of this "off-time" was spent on the flight deck for whatever diversion we could find whether it be walking around, taking photos of planes, or sunbathing on the flight deck. Any "off-time" we might have during the line periods was spent on Vulture's Row watching flight ops. Basically, we came in contact and touched virtually everything on the ship.

Toxic Exposure Rule Comments

We were cross contaminated by variety of different methods

1. Air drift it is documented that about 13% of agent orange dropped on Vietnam was carried out to sea in the Gulf of Tonkin exposing ships that were at sea.

2. Inland water ways that were contaminated by Agent Orange spray made its way to the Gulf of Tonkin and the ship's desalination process did not eliminate the toxins during the process, this is backed by the Australian government report that stated that the process actually increased the toxicity of the chemicals. 3. Unreps (underway replenishment) by cargo ships that got supplies from ports in Vietnam such as DaNang the most contaminated port in Vietnam. We received cargo, food supplies, water, fuel and ammunition (bombs) that was heavily contaminated. For example bombs were stored in passage ways to chow halls, we sat on and leaned on as we waited in line to eat.

4. COD deliveries, personnel, equipment, and mail this was on a daily basis all were exposed and contaminated by Agent Orange

5. Laundry all personnel laundry was washed together Aircrew which worked on aircraft and clothing contaminated by Agent Orange off of aircraft they worked on was all washed together contaminating everyone's clothes.

This occurred during my time on either the USS Constellation or USS Kitty Hawk during the 1968 and 1969 WesPac deployments

Served aboard the USS Constellation and the USS Kitty Hawk both ships were exposed to direct contact of agent orange by means of supplies delivered to ships through unreps (underway replenishment) that originated in Vietnam produce, bombs, food supplies, contaminated water and mail all exposed to agent orange spraying. Aircraft returning from missions covered with spray, Gulf of Tonkin polluted water that was desalinated by ships desalination process which didn't eliminate toxins food prepared with this water as well as it was our drinking, bathing and laundry water. Bombs were stored in passage ways which we came into contact with they were covered by a sticky layer which had a petroleum smell. This is just a brief description of my contact with agent orange.

I honestly don't recall any sticky substance on the bottom of the fuselage other than engine oil and hyrdraulic fluid. We did clean the aircraft by hand using waterless cleaner and rags, so if there was any said sticky substance on the aircraft, we would have been exposed to it by direct hand contact.
